Introduction

Crosby Camera Club is a not-for-profit Community Club/Association run by volunteers for the benefit of the Members.

Crosby Camera Club understands your concerns over the privacy of Personal Data you may provide to us as part of our day to day dealings with you. We will only collect and use information in ways that are useful to you and in a manner consistent with your rights and our obligations under the law.

This policy provides you with information about what types of information are collected, retention periods and other elements to comply with the EU-Wide General Data Protection Regulation as enacted within the UK's Data Protection Act 2018.

If you are dissatisfied with this response you may request that your complaint be escalated, in which case it will be escalated to The President who will review your complaint and the initial response and provide a further response within 28 days of your request to escalate the matter.

Key Terms

The following terms are used or referred to in this privacy notice – as such it helps to be familiar with these core terms (additional definitions may be found within GDPR – Article 4): -

- *'Data Subject'* – The individual about who the data is held.
- *'Data Controller'* – company/individual that determines the purposes and means of the processing of personal data.
- *'Data Processor'* – Company/Individual which processes personal data on behalf of the controller. This is typically a company that provides third party services e.g. IT company.
- *'Consent'* of the data subject means any freely given, specific, informed and unambiguous indication of the data subject's wishes signifies agreement to the processing of personal data relating to him or her.

How and Where we store your data

We only keep your data for as long as we need to in order to use it as described in this policy, typically per statutory requirements and/or as long as you are an active Member allowing for subsequent retention in line with accounting norms.

Data security is of great importance to Us, and to protect your data, We have put in place suitable physical, electronic and organisational procedures to safeguard and secure data your personal data.

Some examples of steps we have taken to secure your data include (but are not limited to) :-

- Physical access control. Records access limited to approved Club Volunteers. PII Records kept in locked or secure filing locations.
- Secure destruction of documents containing PII once no longer required.

Some of your data may be stored within AES or similar Encrypted backups provisioned outside of the EU with a U.S.-EU Privacy Shield Framework compliant backup provider.

Data Retention Policy

We only keep your data for as long as we need to in order to use it, and/or for as long as we have your permission to keep it. In any event, We will conduct an annual review to ascertain whether we need to keep your data. Your data will be deleted if we no longer need it in accordance with the terms of our Data Retention Policy.

Some of your personal data may need to be kept to meet either contractual or legal requirements – please contact us if you have any detailed queries.

The information we collect and the reasons why

Personal Data (PII) is anything which identifies you as an individual, either on its own or by reference to other information. If you are engaging with us to provide services this also applies to any information you share with us.

In some cases, the collection of data may be a statutory or contractual requirement, and we will be limited in the products and services We can provide you without your consent for Us to be able to use such data.

We collect data from you in order to be able to provide you with Membership of Crosby Camera Club.

The Club employs no staff, undertakes no official travel and does not operate its own premises. Accident Books & Premises records are those of the providing organisation. Data within the Club is used for the purpose of administering Memberships and the entering of internal & affiliated Photographic Competitions/Exhibitions.

The Club categorically does not sell Member details. Competition entries are anonymised where appropriate. Member names & photographic works may be publicly shared for celebratory, recognition & publicity purposes.

Our Website

We have a website which also collects details about you including your IP address and we may also use a technical feature called a cookie to record your visits.

We will only use your personal data for providing and managing access to our website and if appropriate tailoring your experience whilst visiting.

What Cookies Do We Use and What For?

Our Site may place and access certain first, second or third party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our services. For more details, please refer to the appropriate sections. We have carefully chosen these Cookies and have taken steps to ensure that your privacy is protected and respected at all times.

Our site triggers a Privacy awareness banner notice to new visitors. This makes use of the following cookie to determine preferences & visit status.

Cookie: hu-consent

The Wordpress CMS uses a *functional* cookie that requires no consent and tests whether the browser is capable of accepting cookies.

Cookie: wordpress_test_cookie

You can choose to enable or disable Cookies in your internet browser. Most internet browsers also enable you to choose whether you wish to disable all cookies or only third party cookies. By default, most internet browsers accept Cookies but this can be changed. For further details, please consult the help menu in your internet browser or the documentation that came with your device.

You can choose to delete Cookies at any time however you may lose any information that enables you to access Our Site more quickly and efficiently including, but not limited to, login and personalisation settings.

It is recommended that you keep your internet browser and operating system up-to-date and that you consult the help and guidance provided by the developer of your internet browser and manufacturer of your computer or device if you are unsure about adjusting your privacy settings.

Please note that cookies may be renamed & that the above list may not be exhaustive as to future changes that may arise due to changes made by software components or plugins. At any time, currently used Cookies may be determined by use of your browser developer tools or cookie audit websites.

Marketing

As a non-profit organisation, Crosby Camera Club does not undertake marketing in the usual commercial sense. We do however seek to promote Membership & Club activities and may make occasional sales of photographic works to non-members.

We will market to existing members where the information/notification is related to existing club services & activities only.

For sales related marketing activities - we will require consent and for you to take an affirmative action, furthermore you will have the option to opt-out (unsubscribe at any point). As per your rights – you may also object to direct marketing and we will cease all related activities (unless they impact our ability to deliver our contracted services to you – if you are an existing customer).

We will also market to you in relation to services and products we offer, where we have a commercial agreement/contract with you.

Data Processing where we are the Data Processor

We process the following personal data where the documented purposes of processing are to enable us to provide you membership services.

Data Processing where we are the Data Controller

Lawful Basis

Any personal data that is collected/processed must be processed in a lawful manner, this section informs you of the basis we have selected.

There are two types of personal data, standard data like names/addresses etc, as well as special categories of data which includes medical/biometric etc – to process this type of data we need to meet an additional legal basis.

Personal Data

We process the following personal data where the lawful basis is *Consent* where the documented purposes of processing is providing membership services :-

- Name & Contact Details
- Payment Details
- External Competition entries

We process the following personal data where the lawful basis is *Performance of a Contract* where the documented purposes of processing is providing membership services :-

- Name & Contact Details
- Payment Details
- External Competition entries

There is no processing of Special Category Data.

Data Sharing (where we are the Data Controller)

In certain circumstances We may be legally required to share certain data held by Us, which may include your personal information, for example, where We are involved in legal proceedings, where We are complying with the requirements of legislation, a court order, or a governmental authority. We do not require any further consent from you in order to share your data in such circumstances and will comply as required with any legally binding request that is made of Us.

We may contract with third parties to supply products and/or services to you on Our behalf. These may include payment processing, delivery of goods, advertising and marketing. In some cases, the third parties may require access to some or all of your data. Where any of your data is required for such a purpose, We will take all reasonable steps to ensure that your data will be handled safely, securely, and in accordance with your rights, Our obligations, and the obligations of the third party under the law.

We will only share data with third parties to enable us to provide our services as previously described.

- Your data may be visible to professional advisors (eg Accountants) or for audit purposes.

If we decide to change the services under our control & influence which process personal data we will request authorisation in advance (where required for that lawful basis) and undertake a DPIA if appropriate.

What Happens If Our Organisation Changes Hands?

We may, from time to time, expand or reduce Our organisation (through merger for example) and this may involve the sale and/or the transfer of control of all or part of Our organisation. Data provided by users will, where it is relevant to any part of Our organisation so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use the data for the purposes for which it was originally collected by Us.

In the event that any of your data is to be transferred in such a manner, you will be contacted in advance and informed of the changes.

Your rights

As an individual you have rights associated with your data :-

1. **Right of access by the data subject** . You (the data subject) shall have the right to obtain from the *controller* confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data and related information.
2. **Right to Rectification** – from the *controller* without undue delay the rectification of inaccurate personal data concerning him or here
3. **Right to Erasure** – the right to obtain from the *controller* the erasure of personal data concerning him or her without undue delay – subject to suitable grounds.
4. **Right to Restriction of Processing**– the right to obtain from the controller restriction of processing where certain rules apply
5. **Right to notify any recipients** – who we share data with in relation to the GDPR Articles 16, 17 and 18.
6. **Right to data portability** – to receive personal data concerning him/her which they have provided to a *controller*

7. **Right to Object** – on grounds relating to his/her situation
 - where the lawful basis is legitimate interests.
 - applies to direct marketing purposes.

Changes to Our Privacy Policy

We may change this Privacy Policy as we may deem necessary from time to time, or as may be required by law. Any changes will be immediately posted on our website & promulgation to members and you will be deemed to have accepted the terms of the Privacy Policy on your first use of our services following the alterations.
